Grants support multi-hazard mitigation planning and implementation activities including property acquisition/demolition, safe rooms, project scoping for studies, and updates to required hazard mitigation plan updates. The Indiana Department of Homeland Security agency bundles local applications into a single application to FEMA.

  - Rail/Highway Crossings Program (Section 130)
  - Surface Transportation Block Grant Program
  - STBG Off-System Bridges Program
  - Transportation Alternatives Program

Federal funds are suballocated through Metropolitan Planning Organizations (MPO) to communities. INDOT distributes funding directly to Local Public Agencies in rural communities not served by an MPO. **\$\$\$**
