During the last couple weeks, the contractor continued addressing punch list work, placed topsoil along roadway shoulders, and continued turf restoration efforts.

Re: **Reminder to Connect to City Water and Sanitary Sewer by October 14, 2029**

Dear Homeowner:

The purpose of this letter is to provide a friendly reminder that you will need to connect to city water and sanitary sewer by October 14, 2029. This notice serves as the five-year reminder for your private connection to the new water and sanitary sewer system that was installed in your neighborhood in 2024.

The Baxter City Council set a 5-year period for property owners to connect to City sanitary sewer and water systems. As such property owners must connect and activate their private service connections to the City water and sanitary sewer systems by October 14, 2029.

As a homeowner, it is your responsibility to hire a contractor to complete your private connection to the City's sanitary sewer and water system. Enclosed is the most current list of licensed and registered excavating contractors who have previously completed this type of work in the City of Baxter. Please note the listing fluctuates as contractors register for the 2025 construction season. Any contractor who has a current pipelayer certification and registers with the city may be added to the list.
