<u>Jen Kader</u>: Kader represents environmental organizations on the Council and is Senior Program Manager at Freshwater in St. Paul. She is a trained and practiced process facilitator whose work

involves strategic and collaborative planning efforts for the purpose of improving surface water quality, ensuring safe and reliable groundwater for future generations, increasing climate resilience of our natural and built water systems, and enhancing the governance of water at state and local levels.

<u>Jen McEwen</u>: McEwen is the Minnesota State Senator for District 7, which includes most of Duluth. She is a Duluth native who earned her law degree from Hamline School of law and has worked in Duluth as an attorney. McEwen served as ranking minority member on the Senate Labor and Industry Policy Committee and also serves on the Senate Environment and Natural Resources Policy and Legacy Committee; and Transportation Finance and Policy Committee. She also serves as a Senate representative on the Minnesota Clean Water Council.

<u>Paul Gardner</u> has held the position of Administrator since January of 2019. He spent 20 years in the recycling and solid waste industry, including as Executive Director of the Recycling Association of Minnesota (RAM). Gardner served in the Minnesota House of Representatives from 2007 to 2010, representing part or all of six communities in Ramsey and Anoka Counties. Originally from the Virginia suburbs of Washington, DC, Gardner has lived in Shoreview since 1997. He holds a B.A. from Grinnell College in Iowa and an M.P.A. from the Humphrey Institute of Public Affairs at the University of Minnesota. Grants must be awarded to local government units for projects approved by the Voyageurs National Park Clean Water Joint Powers Board and must be matched by at least 25 percent from sources other than the clean water fund.

I appreciate the opportunity to speak again today to the Board. The potential annexation of Kicker Blvd. by the CLWSD continues to be opposed by Kicker Blvd residents but I am here today to introduce a possible solution not only for Kicker Blvd residents but the entire comprehensive planning area. I will be brief and high level so as not to take up too much of your time.

In a nutshell my plan revolves around the JPB securing grants to be able to offer incentives to property and business owners in the comprehensive planning area who are not otherwise connected to a centralized waste-water processing system. Under this concept a property owner could apply to receive a percentage, say 1/3 or the cost of installing a new or upgraded waste treatment system up to a max amount, say \$20,000. Of course, all such systems must comply with the applicable existing State and County regulations for such systems. The processing and administration of these grants would be handled by any of the local sewer districts within the comprehensive plan area. As compensation for administering the rebate program, each successfully processed application would result in that sanitary district receiving a one-time \$7,500 fee for their services. This is really no different than a federal rebate incentive program for installing solar panels on your home.

This is truly a Win-Win-Win

The JPB wins in many ways. First a \$1 million of grant now results in \$3 million of upgrades across the system. Second, the first come first served nature of the grant money creates scarcity and therefore encourages upgrades or installations sooner rather than later. Lastly, and most importantly, increased water quality across the area.

Local Sanitary districts win because they get a cash infusion into their systems for working with and assisting property owners in the community apply for the grants. They also save the time, hassle, expense, and liability of trying to service remote waste treatment systems in their area.

Property owners win, because the cost to install these systems in greatly reduced and there are no longer-term payments, taxes or additional regulations put upon their property.

The fact that the JPB has been able to secure over \$25 million in grants in support of the comprehensive plan to date is both commendable and enviable. I believe a uniform, equitable and comprehensive proposal like I just set forth that applies to all properties in the Comprehensive Plan Area would be well received by both property owners and those making the decisions to grant money towards this cause.

I would be happy to take any questions or hear any comments. As a quick disclaimer, with respect to this concept, these thoughts are my own and not necessarily reflective of the 25 properties on Kicker Blvd that continue to oppose annexation.

VNP CLEAN WATER JOINT POWERS BOARD MEETING December 16, 2020

The monthly meeting of the VNP Clean Water Powers Board was held on December 16, 2020 as a Virtual Videoconference Meeting. The meeting was called to order at 10:06 by Chairman Pavleck. Board members also present were Commissioners McDonald, and Nelson. There was a public comment from Jay Kanive related to Kicker Blvd Annexation at the Crane Lake Sewer District. Commissioner Pavleck differed the comment to the Other Business segment of the agenda.

The project is currently in a waiting period as site access permissions remain from some property owners before archaeological field work can be performed.

Rob Scott informed the group that the current resolution for kicker blvd annexation has been tabled. There will be a 2nd public hearing regarding this annexation in the future. The district is currently proceeding with engineering design of WWTP improvements related to influent flow equalization. There were 5 managed ISTS installed in 2020 and the district intends to construct approximately 6 more ISTS during the 2021 construction season.

Dear Mr. McDonald, Mr. Paveleck and Crane Lake Water and Sanitary District Board Members:

We, the undersigned, are writing to inform you of serious concerns on the need, motives and process with respect to the Crane Lake Water and Sanitary District's ("CLWSD") proposed annexation of Kicker Blvd.

First and foremost, is was surprising to learn at the September 2, 2020 CLWSD Meeting (the "Meeting") that there was no environmental impact study or water quality study conducted to specifically assess the potential need to annex Kicker Blvd on the basis of environmental impact or the public health and welfare. There is actually evidence to support that water quality along Kicker Blvd. is not only high, but potable. The owners of 737 Kicker Blvd. tested water pulled from the lake this year and found that it was safe to drink. It is hard to imagine there is a water quality issue on Kicker Blvd. when owners are pulling potable water directly from the lake.

Secondly, a major selling point of this proposed annexation seems to be the promise of a "free" septic system with membership. As a citizen astutely pointed out in the Meeting, the all in first year costs of installing a septic system under the CLWSD's current program approaches over 50% of the cost of a typical system and then the owner of that system is on the hook for annual payments of roughly \$1,200/year thereafter for life. We request that a fulsome disclosure of all the costs of installing, maintaining, and operating a septic system under the CLWSD ordinances for the life of a system should be provided. This analysis should also (i) clearly illustrate a range of additional costs outside of the CLWSD charges for which a property owner is expected to be liable and (ii) incorporate any special or new charges anticipated by the CLWSD to service properties on Kicker Blvd since it is not connected to the centralized system and only accessible by water.

Third, having the "option" to join a sewer district for the price of \$7,500 plus over \$1,000/year in annual fees for a property owner that already has a working septic system is not really an option at all. Literally, no services are provided to such a property owner by the CLWSD in exchange for a rather large sum of money. Hopefully, this is clear that such a situation is inequitable. There is also no reason for even creating the aforementioned situation because Minnesota Statute 442A.05 Subd. 1 subpart (b) expressly states that an annexation can be effected on "... an area or a group of two or more adjacent areas, whether contiguous or separate, ..." Given this express ability to annex non-contiguous areas, there appears to be no logical reason to annex any property that does not want to be annexed. The only requirement it seems from the Statutes is that there would be at least two parcels annexed This course

of action is further supported by the fact that there is no infrastructure connecting the proposed area(s) to any centralized system. There is not even a road connecting the individual parcels. No good reason was given at the meeting as to why individual parcels could not be annexed by choice.

Fourth, the fee and tax structure of the proposed district is not equitable. Taxing properties in the district for administrative expenses on the basis of property values for a sewer and sanitary district is not equitable. The electric company does not assess a fee for service based on the value of properties, why should the sewer and sanitary district be any different? The administrative fees should be based on something like Equivalent Domestic Units as such term is defined in the CLWSD ordinances. Additionally, it appears that properties that choose to join the CLWSD are charged a monthly fee year-round. This type of fee structure strikes us as extremely inequitable for seasonal cabins that are not even physically hooked up to the centralized sanitary system. Furthermore, it seems preposterous to charge the same monthly fee to the owner of a septic system as for an owner hooked up to the centralized system. The CLWSD is not really providing the owner of a septic system any monthly service. The entire idea of Kicker Blvd. "hooking up" to the CLWSD system seems to be nothing more than a legal fiction.

Finally, we note that the Meeting failed to provide all the information as expressly required by Minnesota Statute 442A.05 Subd. 2 subpart (b). Minnesota Statute 442A.05 Subd. 2 subpart (b) states that: "At the meeting, information must be provided, including a description of the existing sanitary district's structure, bylaws, territory, ordinances, budget, and charges; a description of the existing sanitary district's territory; and a description of the territory of the proposed annexation area." Information we would like to be provided, includes, but is not limited to, (1) evidence of CLWSD's financial and managerial resources to deliver adequate and efficient sanitary sewer services as required by the Statutes, (2) balance sheet as of December 31, 2019, statement of revenues, expenditures, and changes in fund balances for the years 2017-2019, budget to actual comparisons for previous 5 years, 2020 budget schedule and five year capital plan, (3) a fully executed copy of the current ordinances in effect and (4) a copy of the bylaws for the CLWSD.

Based on the above there seems to be a lot of work that still needs to be done before the CLWSD could legally, and in good faith, even consider drafting a petition under the Minnesota Statutes proposing the annexation of Kicker Blvd. At this time, we respectfully request that the CLWSD discontinue any efforts to move forward with annexing Kicker Blvd. If the CLWSD were to move forward at all, it should only be with those property owners willing to be annexed using the "non-contiguous" clause of the Statutes.

We respectfully request your response prior October 1, 2020, or prior to any such rescheduling of a meeting to correct the information deficiency of the meeting that took place on September 2, 2020. Thank you.

Can you please share this brief update with the Joint Powers Board at this week's meeting? Due to the legislature's special session this week, Gary and I will be unable to attend the meeting.

Update

The Clean Water Council Budget and Outcomes Committee met Friday (7/11) to discuss specific projects and make tentative funding recommendations. Our project, along with 70+ other programs and projects were discussed. No questions were asked about our project and the committee recommended a funding level of \$1.55 million dollars (we had applied for \$2.2 million) asking that we tier and prioritize work based on a \$1.55 million funding level. We are making progress, but this process remains competitive. Due to COVID and state budget changes, the funding available may continue to shift.

Clean Water Council Executive Director Paul Gardner did note that our group effort and letters of support were impressive and effective. It was nice to speak with you today, and share some history about the Range! I am sorry that the reason for my

call was such unfortunate news, though.

As we discussed, the February 2020 Budget and Economic Forecast projected a positive balance in the Clean Water Fund (CWF); however, in light of the economic slowdown related to the COVID-19 pandemic, Minnesota Management and Budget (MMB) assumes that actual sales tax receipts will decline substantially from what was anticipated in the February forecast. Because of this anticipated decline in receipts, MMB is asking agencies to take proactive steps to prevent a deficit from occurring in the CWF. All state agencies received a message from MMB requiring an immediate halt to executing new grants or contracts with CWF (or sometimes called Legacy funds). MMB is currently evaluating remaining funds within the CWF, and considering how to move forward.

The \$775,000 that was appropriated for sanitary sewer projects described in the Voyageurs National Park Clean Water Project Comprehensive Plan for fiscal year 2020 (FY20) is comprised of Clean Water or Legacy funding. Some of this funding - \$300,000 – is included in a grant that was previously executed, and this grant funding is not affected by the directive from MMB. That \$300,000 grant project can move forward as planned. Funds can be spent on activities described in the grant. The remaining \$475,000 of this FY20 appropriation, though, is essentially frozen – we cannot move forward with executing a grant with these funds at this time. It is possible that the FY21 appropriation of \$775,000 may be impacted, as well.

It is not clear how long MMB's evaluation of the CWF will take or when state agencies will be given approval to move forward with spending Clean Water Funds. I'll be in touch as we get information from MMB. In the meantime, if you have any questions, please feel free to contact me.

Subordinate Service Districts F, G, H and J

- These subordinate service districts were officially established by the Township in November 2019. The district boundaries roughly correspond to the service area boundaries established in the Comprehensive Plan.
- 2.7 miles of shoreline; 78 property owners, 99 parcels, 6 resorts, 1 bar/restaurant, VNP visitor center.
- Potential to add 22 offshore properties and 2 shoreline resort properties between H an G.
- The Kabetogama Clean Water committee visualizes these 4 service districts combined into one or two projects to be completed in the next 10 years. Engineering recommendations needed.



Service Area C

- Establishment of the subordinate service district in area C has been held up due to a reverse referendum petition. The property owners of this Area will be voting on the issue of establishment on May 12 of this year. 63% of the property owners petitioned to establish the service district so we are expecting a favorable vote for establishment.
- One mile of shoreline; 24 property owners, 24 parcels. No commercial
- The Kabetogama Clean Water committee visualizes this area as one project to be completed in the next 10 years.



<u>Area A</u>

- We have not begun the process of organizing Area A yet. We will start our organizing of this area into a subordinate service area once we get a progress track on FGHJ and C.
- 1.5 miles of shoreline; 40 properties, 5 resorts.
- The Kabetogama Clean Water Committee visualizes a project started on this Area within the next 10 years. There is potential for this area to share the treatment facility at Puck's Point (Area B). Engineering recommendations needed.

Dear Chair Jewell and Administrator Gardner:

Thank you for recently meeting with members of our team to discuss the Clean Water Council's FY2021-22 funding process for the Clean Water Legacy funds. We appreciate you taking the time to discuss our project and its very positive impact on the waters of Voyageurs National Park (VNP) and the Boundary Waters Canoe Area Wilderness (BWCAW).

As you are no doubt aware, Minnesota has only one National Park, Voyageurs National Park. It is the nation's only water based national park, and it is proudly acclaimed for its beauty and pristine nature. More than ten years ago, counties, townships, and unorganized areas adjacent to the Park came together and locally formed Voyageurs National Park Clean Water Project Joint Powers Board (VNPCWPJPB). This Board has directed efforts to develop a comprehensive plan to clean up and protect the waters of VNP at the four main public access points to the park.

The Board has had great success, establishing sanitary sewer districts and projects in three of the four main entrances to the Park. We have worked with the Minnesota Pollution Control Agency, Public Facilities Authority, U.S. Department of Agriculture, U.S. Army Corp of Engineers, the Minnesota Clean Water Council, and many others to bring funding to these urgently needed

projects that provide guests to VNP the sanitary solutions so important to them and to the Park. Our work needs to continue in four main areas:

- A sanitary sewer district at the unorganized area of Ash River has been established.
 The Ash River Sewer District is currently completing their facility plan and is starting the design of their project. The total project cost is estimated to be \$12.5 million dollars and will consist of the design and construction of a new collection and treatment system.
- 2. Phase I of the expansion of the Pucks Point Sanitary Sewer System in Kabetogama Township, where another entrance to the Park and a state campground is located, has been completed. Kabetogama Township is now undertaking Phase II of their sanitary system improvements. The total estimated cost for this project is \$13 million dollars and the township will be completing a facility plan and preliminary design.
- 3. The Crane Lake Sanitary Sewer district has completed a number of collection and sewer projects over the last many years. The sanitary sewer district has established a sanitary sewer treatment system (SSTS) program that helps residents replace their current failing septic systems. The sewer district will need to recapitalize the program at the amount of \$600,000 in order to replace additional systems in the service area. The Crane Lake area is also home to a public access area to both VNP and the BWCAW.
- 4. Koochiching County has recently completed Phase I of their Island View Sanitary Sewer Project which extended a sewer collection system to an area in their service district that consisted of failing SSTS systems. This extension allows for the elimination of existing, failing septic systems and allows for residents to connect to an existing wastewater treatment facility. They will now begin the design and construction of Phase II of this project at a total estimated cost of \$3 million dollars. The extension of this sewer connection line will allow these underserved residents to connect to the existing treatment system.

To these ends, it is essential to our work that the Council continue funding for the National Park Water Quality Protection Program at \$2.2 million in FY 21-22 and at that level for the 5-year period. Our board has a proud record of developing and constructing viable and sustainable sewer projects and is dedicated to completing their mission as identified in the comprehensive plan.

The development and completion of this plan was done in coordination with local governments and residents/guests and businesses, and state and federal agencies to improve the water quality of this national treasure. Most Minnesotans would agree that protection of the water flow into the Voyageurs National Park and the adjacent flowage into the Boundary Waters Canoe Area Wilderness should be a high priority for the Council.

Our work is driven by the goal to protect this asset for Minnesotans and the Nation. We formally request that the Council consider our funding request for FY21-22 and beyond. We would also request that the Council inform us of any necessary steps we must take in the process to be included in the Council's FY21-22 funding recommendations to the Minnesota Legislature. Please notify us when you wish to hear a presentation of this proposal.

Let us protect these treasured waters, together.

Most importantly, we greatly appreciate the past support for the National Parks Program by the Council and the Legislature.

VNP CLEAN WATER JOINT POWERS BOARD MEETING November 20, 2019

The monthly meeting of the VNP Clean Water Powers Board was held at Thunderbird Lodge in International Falls, MN on November 20, 2019. The meeting was called to order at 10:05 by Chairman Pavleck. Board members also present were Commissioner McDonald and Commissioner Jugovich. Commissioner Pavleck welcomed everyone to the meeting and thanked all of the office and departmental representatives for attending. There were no public comments and all attendees introduced themselves.

A motion was made by Commissioner McDonald and supported by Commissioner Jugovich to approve the October 16, 2019 minutes with an amendment identified by Mark St. Lawrence.

The amendment clarified that previous minutes stated that there would be a reallocation of funding from the Ash River and Crane Lake Projects in the amount of \$23,750 from each project. Mark identified that that amount did not account for the local match. The correct amount was \$17,812.50 to be re-allocated from each project to the Comprehensive Plan.

All voted in favor.

Comprehensive Plan. Mark St. Lawrence indicated that both Koochiching County and St. Louis County have made their local match contributions. Jason and Mark will be contacting Dave at the MPCA to discuss how to proceed with the contract amendment, establish the work plans and grant agreements.

Ash River. Mark St. Lawrence informed the group that the newly formed board met in late October. The board established officers and are reviewing draft ordinances and by-laws. They will be holding regular meetings the first Monday of the Month starting in The DNR is currently reviewing appraisals and is in on schedule for final approval March 2020. Colin from SEH had a conference call with the Ash Board on November 14, 2019 and provided them with a memo outlining the current status of the facility planning and design phase. The board asked Colin to request a services proposal from Mia at Fryberger Law for legal and easement assistance.

Kabetogama. No current updates. Jason provided a brief review on the status of Phase 2 Kabetogama that John provided at the September 2019 meeting.

Crane Lake. Jason provided an update from Rob Scott. 8 ISTS systems were installed in the 2019 construction season bringing the district total to 40. The district anticipates the installation of 6-10 new systems during the 2020 construction season. The district also anticipates completing the Kicker Blvd Annexation in 2020. This annexation will bring up to 20 additional ISTS systems from the 35 users in that area. Rob also bring to the JPB attention the challenges the CLWSD has with the inability to inspect existing ISTS systems with the district area for conformance. The district is not authorized to have private existing systems inspected for compliance under Ordinance 61.

Koochiching. The project is nearly complete with exception of 1grinder station and some additional work that will extend Contract A into the month of December. There is still a large amount of restoration work that will be completed by Contract A and B in the spring of 2020.

Project Funding. Jeff Anderson informed the group they will be meeting with the new director of the clean water council on November 21, 2019.

DNR. Nothing to report.

MPCA. Nothing to report.

VNP. Bob informed the group that the VNP will be meeting with the MPCA to discuss potential gray water management plan within the park for houseboats, islands, fish houses, etc.

Mark St. Lawrence presented current invoices from Costin Group and SEH. A motion was made by Commissioner McDonald and supported by Commissioner Jugovich to approve the presented invoices. All voted in favor.

Other Business.

None.

The next planned meeting is scheduled for January 15, 2020 at 10:00 AM at the Public Works Facility in Cook.
